ORDER

UPON THE PART 8 CLAIM made by Hartley Pensions Limited (in administration) ("**HPL**"), Peter Kubik (as Joint Administrator of the First Applicant) and Brian Johnson (as

Joint Administrator of the First Applicant) (together, the "Applicants"),

AND UPON HEARING Adam Al-Attar for the Applicants; George Rowell for the original proposed Representative Respondents; Kate Rogers for the new proposed Representative

Respondents; and Peter Arden KC for RL360 Insurance Company Limited and Ardan International Limited,

AND UPON READING the Part 8 Claim and the evidence filed,

AND UPON ADOPTING the defined terms in the Part 8 Claim,

IT IS ORDERED THAT:

- 1. The following applications shall be listed for a one-day hearing on an expedited basis in a three-day window between 5 and 7 February 2024:
 - the Claimants' application dated 22 December 2023 for the appointment of the original proposed representative respondents (and associated relief);
 - (2) the Claimants' application dated 18 January 2024 for the appointment of the new proposed representative respondents (and associated relief);
 - (3) the original proposed representative respondents' application dated 5 January
 2024 for additional time to file evidence (should they be appointed representative respondents);
 - (4) Any application by RL360 Insurance Company Limited and/or Ardan
 International Limited (a) for permission to be joined to the Part 8 Claim or (b) for
 permission to issue the application referred to in (a) and for that application and
 the application referred to in (a) to be dealt with on a rolled-up basis.
- 2. Any evidence in answer to the above applications shall be filed and served by 4pm on the date three clear days in advance of the hearing fixed under paragraph 1.
- 3. Skeleton arguments in reference to the above applications are to be filed and exchanged by 4pm on the date one clear day in advance of the hearing fixed under paragraph 1.
- 4. The Part 8 Claim will remain set down for a hearing with a time estimate of 2 days floating in a three-day window commencing on 29 February 2024, with ¹/₂ a day's judicial reading time in addition.
